## **Purpose**

The purpose of this privacy policy (this "Privacy Policy") is to inform users of our Site of the following:

- 1. The personal data we will collect;
- 2. Use of collected data;
- 3. Who has access to the data collected;
- 4. The rights of Site users; and
- 5. The Site's cookie policy.

This Privacy Policy applies in addition to the terms and conditions of our Site.

## **GDPR**

For users in the European Union, we adhere to the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, known as the General Data Protection Regulation (the "GDPR"). For users in the United Kingdom, we adhere to the GDPR as enshrined in the Data Protection Act 2018.

We have not appointed a Data Protection Officer as we do not fall within the categories of controllers and processors required to appoint a Data Protection Officer under Article 37 of the GDPR.

#### Consent

By using our Site users agree that they consent to:

1. The conditions set out in this Privacy Policy.

When the legal basis for us processing your personal data is that you have provided your consent to that processing, you may withdraw your consent at any time. If you withdraw your consent, it will not make processing which we completed before you withdrew your consent unlawful.

You can withdraw your consent by: Declining when first on site.

## **Legal Basis for Processing**

We collect and process personal data about users in the EU only when we have a legal basis for doing so under Article 6 of the GDPR.

We rely on the following legal basis to collect and process the personal data of users in the EU:

1. Users have provided their consent to the processing of their data for one or more specific purposes.

### **Personal Data We Collect**

We only collect data that helps us achieve the purpose set out in this Privacy Policy. We will not collect any additional data beyond the data listed below without notifying you first.

## Data Collected Automatically

When you visit and use our Site, we may automatically collect and store the following information:

- 1. IP address;
- 2. Location;
- 3. Hardware and software details;
- 4. Clicked links; and
- 5. Content viewed.

## Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site:

- 1. First and last name;
- 2. Email address;
- 3. Phone number;

- 4. Address; and
- 5. Payment information. (We do not collect or store full payment card details. All payment information is processed securely by our third-party payment processors (such as Wix Payments, Square, or Clover), and we only receive confirmation of payment along with limited information such as the last four digits of the card.)
- 1. Subscriptions, contact forms, and checkout process; and
- 2. Payment information is submitted securely through third-party payment processors.

## **How We Use Personal Data**

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for the following purposes:

1. To analyze website traffic, improve site performance, understand user behavior, and enhance user experience.

The data we collect when the user performs certain functions may be used for the following purposes:

- 1. To process and fulfill customer orders;
- 2. To communicate with customers; and
- 3. To manage payments and prevent fraud.

#### **Who We Share Personal Data With**

#### **Employees**

We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

## **Third Parties**

We may share user data with the following third parties:

1. WIX.

We may share the following user data with third parties:

- 1. Payment information (Processed by Wix, Square, or Clover);
- 2. Customer contact information (name, email, phone number, address); and
- 3. Automatically collected technical date (IP address, device type, browser info).

We may share user data with third parties for the following purposes:

- 1. To securely process payments and prevent fraud;
- 2. To fulfill orders, including shipping, and customer communication; and
- 3. To analyze website usage and improve site performance.

Third parties will not be able to access user data beyond what is reasonably necessary to achieve the given purpose.

### Other Disclosures

We will not sell or share your data with other third parties, except in the following cases:

- 1. If the law requires it;
- 2. If it is required for any legal proceeding;
- 3. To prove or protect our legal rights; and
- 4. To buyers or potential buyers of this company in the event that we seek to sell the company.

If you follow hyperlinks from our Site to another Site, please note that we are not responsible for and have no control over their privacy policies and practices.

## **How Long We Store Personal Data**

User data will be stored until the purpose the data was collected for has been achieved.

You will be notified if your data is kept for longer than this period.

## **How We Protect Your Personal Data**

Wix takes several measures to protect users on their sites:

- Dedicated Security Team: Experts in information, application, and network security who constantly monitor and improve defense systems.
- Compliance and Certifications: Wix is PCI Level 1 compliant and certified for ISO 27001, ISO 27018, and other standards.

- Physical and System Access Controls: Hosted on secure AWS and Google Cloud data centers with strict access policies.
- Application Security: Includes two-factor authentication, regular vulnerability scans, and penetration tests.
- Data Protection: HTTPS is enabled by default, and all critical data is protected with TLS v1.2 or higher.

While we take all reasonable precautions to ensure that user data is secure and that users are protected, there always remains the risk of harm. The Internet as a whole can be insecure at times and therefore we are unable to guarantee the security of user data beyond what is reasonably practical.

## **International Data Transfers**

We transfer user personal data to the following countries:

- 1. Wix Stores and Processes data in Israel;
- 2. Wix Stores and Processes data in Europe; and
- 3. Wix Stores and Processes data in the United States.

When we transfer user personal data we will protect that data as described in this Privacy Policy and comply with applicable legal requirements for transferring personal data internationally.

If you are located in the United Kingdom or the European Union, we will only transfer your personal data if:

- 1. The country your personal data is being transferred to has been deemed to have adequate data protection by the European Commission or, if you are in the United Kingdom, by the United Kingdom adequacy regulations; or
- 2. We have implemented appropriate safeguards in respect of the transfer. For example, the recipient is a party to binding corporate rules, or we have entered into standard EU or United Kingdom data protection contractual clauses with the recipient..

#### Your Rights as a User

Under the GDPR, you have the following rights:

### Children

We do not knowingly collect or use personal data from children under 16 years of age.
